### Special election on proposed Inclusion will begin this week.

During a non-partisan special election commencing this week, CPNMD voters will determine whether or not to approve the proposed Inclusion of our water and wastewater utilities with those of the Parker Water & Sanitation District.

### CASTLE PINES NORTH METROPOLITAN DISTRICT BALLOT QUESTION 6A

Shall the area within Castle Pines North Metropolitan District which is described below become a part of the Parker Water and Sanitation District for the purpose of obtaining only water and wastewater utility services upon the conditions described below?

The Castle Pines North Metropolitan District is generally located:

East of Daniels Park Road, and West of Interstate 25.

South of the lots on Griggs Road and Tapadero Way; south west of the Public Service Company Power Line Easement and trails; and, south of Charter Oaks Drive and 1st Avenue.

Its southern boundary is generally north of the lots along Chase Lane, Northwood Lane and Country Club Parkway.

The inclusion of the Castle Pines North Metropolitan District into the Parker Water and Sanitation District is subject to the conditions set forth in the Inclusion Agreement between Castle Pines North Metropolitan District and Parker Water and Sanitation District as approved by their Boards on February 8, 2021 and February 11, 2021, respectively. - 2) Week of Monday, April 12, 2021: Ballots will be mailed out to all legally registered CPNMD voters. (Hidden Pointe Metro District residents are exempt from this election.)
- 3) Before returning your ballot, please sign and date the ballot-return envelope.
- 4) To count, voters must return their ballot via U.S. mail or hand-delivery to one of two ballot drop-box locations **before 7:00 p.m. on Tuesday, May 4, 2021**.
